In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala State and Subordinate Services Rules, 1958, namely:—



## RULES

*1.Short title and commencement.*—(1) These rules may be called the Kerala State and Subordinate Services (Amendment) Rules, 2020.

(2) They shall be deemed to have come into force with effect from 30<sup>th</sup> June, 2016.

*2.Amendment of the rules.*—In Part I of the Kerala State and Subordinate Services Rules, 1958, in the SCHEDULE,—

(1) in LIST I, under the heading “SCHEDULED CASTES IN THE KERALA STATE’, —

(a) for the entry against item 29, the following entry shall be substituted, namely:—

“Malayan (in the areas comprising the Kannur, Kasaragode, Kozhikode and Wayanad districts)”;

(b) for the entry against item 30, the following entry shall be substituted, namely:—

“Mannan, Pathiyan, Perumannan, Peruvannan, Vannan, Velan.”

(2) in LIST III, under the heading “OTHER BACKWARD CLASSES IN THE KERALA STATE’, under the sub-heading “1.Throughout the State”, the entry against item 57, “Peruvannan (Varanavar)” shall be omitted.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the Constitution (Scheduled Castes) Order (Amendment) Act, 2016 (24 of 2016) Central Act, the Government of India have substituted the entries 36 and 37 in Part VIII in the Schedule to the Constitution (Scheduled Castes) Order, 1950 as “36.Malayan (in the areas comprising the Kannur, Kasaragode, Kozhikode and Wayanad districts) and 37.Mannan, Pathiyan, Perumannan, Peruvannan, Vannan, Velan”. This Amendment Act came into force with effect from 30<sup>th</sup> June, 2016 as per notification No.S.O.2221(E) dated 28<sup>th</sup> June, 2016 and published in Part II, section 3, sub-section (ii) of the Gazette of India Extra ordinary No. 1600 dated 28<sup>th</sup> June, 2016. The Peruvannan (Varanavar) community was included as item 57 in the List III Other Backward Classes in the Kerala State of the Schedule to Part I of the



Kerala State and Subordinate Services Rules, 1958. As such, the said community has been excluded from the List III of the Schedule to Part I of the Kerala State and Subordinate Services Rules, 1958 with retrospective effect from 30<sup>th</sup> June, 2016 as per G.O(P)No.13/2019/B.C.D.D dated 2<sup>nd</sup> July, 2019. In order to give effect to the provisions of the Constitution (Scheduled Castes) Order (Amendment) Act, 2016 (Central Act 24 of 2016) and to give statutory validity to the above said Government Order the Government of Kerala propose to amend the Kerala State and Subordinate Services Rules, 1958 suitably.

The notification is intended to achieve the above object.
